- 3.1 Update on 20/21 equipment procurement

The site is being erected for the MRI Scanner on Wednesday for Siemens to start work on the Library next Monday. We transfer activity from the level 3 Library once that's up and running, then make changes and put the charitably funded MRI down on to level 3 come January with end of work anticipated April-May time next year.

#### 3.2 Covid Bids

We have purchased some of the Covid related items that we did some substitutions on. There is one of the Microbiology Systems still outstanding but that will be purchased shortly. We are waiting for delivery of 6-7 intensive care Ventilators.

Bariatric Equipment – We have approval from CapCG to proceed with this purchase so that we no longer have to lease Bariatric equipment. That will be 5 beds plus some accessory items. We just need to find some slippage within the current capital programme.

Smoke Evacuation devices have been a challenging procurement process but hope to go out to start the tender process shortly

#### 3.3 Laverstock expansion /ED expansion

We have external funding for both of these programmes. We have a list of equipment we are working our way through Procurement. On the list for Laverstock is a Hemofiltration device and the Ventilators. We are working through whether we can get those.
