Recommendation:

The Board is asked to note the progress of the Trust's significant capital schemes.

Executive Summary:

This capital development report describes the improvements that have been made in the last four months to the estate, across buildings, information technology, medical equipment and infrastructure.

1. Purpose

The purpose of this paper is to update the Board on developments with some of the more significant capital schemes on the Salisbury District Hospital site since the date of the last report in February '18.

2. Building Schemes

Ophthalmology OPD

Project team and users are currently trialing more modern equipment which is more space efficient in some of the consulting rooms with the aim to agree which of the rooms will require some adjustments. Once the evaluations have taken place, costs will be sought to determine the changes required to allow more functionality within the affected consulting rooms.

New Pembroke Ward/Suite Level 3 (former Ophthalmology OPD)

Building work started in the former ophthalmology template level 3 in early November. The contractor completed the works in mid-May which was a month later than was projected due to problems with depth of the drainage channels (a known risk due to the variability in the depth of concrete in the phase 1 building) and the amount of fire stopping which was required to comply with new more stringent building control regulations.

In order to maintain the timeline of the planned moves, Pembroke ward moved to level 3 on the 14th May and the suite moved on the 17th May. The latter proved more challenging for the service and cleaning teams, however due to the excellent support of the teams, the suite was able to be operational on the same day.

The following moves have now taken place:

- Pembroke ward and suite has moved to newly refurbished level 3
- Farley ward has moved to the former Pembroke ward and suite on level 2
- The elderly care ward on level 4 has moved back down to level 2. It will be known as Spire ward
- Laverstock ward on level 4 is currently empty and will be used for decant and possible escalation purposes.

Replacing pipework in Sarum Ward and Children's Outpatients Department (OPD)

There is a requirement to replace all the pipework within the Sarum ward and children's outpatients due to issues with the current pipework having a propensity for leaking. Both areas will be required to decant and it is proposed to decant them to Laverstock Ward. The work is expected to start 18th June and to be completed by late August.

Laverstock Ward will then be available for other purposes beginning September.

3. IT Schemes

The following are the major projects currently underway:

Electronic Whiteboards (eWB)

The project is being progressed with a few technical messaging issues to resolve. It is expected that within 3 months the fully bi-directional eWB should be tested and available for a ward to test fully leading to a potential go-live date of August. This assumes no more significant issues are discovered as SFT is the first hospital to use this functionality. Single flow of messaging (Lorenzo -> Whiteboards) is now more stable and the system being utilised for bed capacity.

Patient Observation and Escalation Tool (POET)

Visual Infusion Phlebitis (VIP) scores are now available for recording on POET. Clinical assistants have been trained to record cannula insertion electronically to aid the recording of VIP score. Following some testing, Zebra devices were chosen as the replacement for the unstable Mios. These have now been ordered and we are awaiting their arrival. The development team are currently adapting the design of POET to enable it to be displayed correctly on the new devices and to facilitate scanning on the Zebra.

Electronic Discharge Summaries

The next set of developments are due for release in early June which will include adaptations to assist with identifying where summaries have not been completed.

NHSmail 2

Due to the infrastructure refresh work, the decision has been made to delay the migration of email accounts to NHS mail until November 2018 as there are a significant number of servers required for the migration.

Health and Social Care Network

The contract for N3 (the national NHS network) ended on 1 April 2017. The service is currently being run by NHS Digital who are moving all organisations from N3 onto HSCN. The first year's funding for the service will come from NHS Digital, with subsequent year's funding being 75%, 50% for years 2 and 3. We are working with our STP partners to ensure that we secure the best possible deal with the Salisbury Procurement Department taking the lead. The procurement is currently underway with a preferred provider due to be selected in June.

Infrastructure Refresh

Following the award of the contract, orders were placed for the replacement core infrastructure and some deliveries to site have commenced. Core data hardware is racked and the build is underway, the new software backup solution is due to be in place by the end of May. The replacement core infrastructure is due to be commissioned on-site early June. Following acceptance testing by the Trust, migrations to the new infrastructure will commence.

4. Medical Devices schemes

2nd MRI scanner campaign

A multi-disciplinary stakeholder group has been implemented to oversee this scheme. The location for the new scanner has been approved and the equipment specification drafted. Procurement processes are being undertaken involving equipment evaluations.

Replacement of Cardiac Catheter Laboratory

A multi disciplinary stakeholder group has been implemented to draft a full business case / options appraisal for the replacement of one of the cardiac catheter labs together with the haemodynamic monitoring system used in both labs

5. Recommendations
